This year, children from the hospital participated in a day of fishing at the private lake of Mr. Marshall Willey. 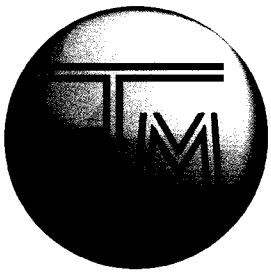
